What is the Fun Funds program?

Your participants simply have to shop at our GFS Marketplace stores. Over 1,000 items in our stores are labeled for the Fun Funds program. Based on the quarterly purchases of your cardholders, **your school or organization earns up to a 10 percent rebate!** All other products earn one percent. The more they spend, the more you earn.

What are the benefits for my school or organization?

Fun Funds is free! There are no costs up front, and our stores don't charge a membership fee. The program is flexible—your participants aren't limited to a small number of items: everyday items throughout our store are eligible. Participants also receive coupons and incentives from the stores to get them in the door and earn more money! Rebates are calculated quarterly, and a check is sent directly to your school or organization.

How do we get started?

Complete the form on the back of this brochure and return it to your local GFS Marketplace store. You'll receive a welcome e-mail when your account has been activated with instructions on how to invite your supporters to join online as members. Members that enroll online will receive two valuable offers: a \$10 discount on their first purchase and a \$10 donation to your organization on their second purchase. You can also order paper enrollment forms for those supporters without Internet access.

What does Fun Funds look like in action?

400: The number of members in your school

40: A given number of members who participate in the Fun Funds program each month

\$40: The amount spent per member each month at GFS Marketplace on Fun Funds items

\$4,800: The combined quarterly purchases of Fun Funds items

\$480: Your quarterly rebate amount (calculated at 10%) to use for any school or organization purchase!

So for about \$40 each month in groceries—burgers, lasagna, pies, chicken breasts, bottled water, chips, and more—for only 40 families, you'll earn almost \$2,000 each year in rebates. But as member enrollment grows to 60, 100, and more members shopping each month, you can watch your profits really soar!

Your organization must reach a combined minimum of \$500 in non-Fun Funds items to earn a 1% cash rebate. Quarterly statements and checks are mailed directly to the organization leader, designated on the Fun Funds Organization Agreement.
